GENERAL INFORMATION

ColourUp contains a unique calcium system which strengthens cell walls, plant and fruit peel tissue on various fruit crops. **ColourUp** is applied as a foliar application and is totally systemic absorbed and has the ability to move in the phloem and xylem of the plant. **ColourUp** is part of Miller Chemicals patented Nutrient Express Technology products and focus mainly on plant energy production.

DIRECTIONS FOR USE

ColourUp should be used on all crops in a foliar application program.

ColourUp should be used on all crops in a foliar application at the rate of 2L/ha. Timely applications give the best results.

Crop	Rate / ha	Timing
Grapes	2 L	1. 1 st at colour break. 2. 2 nd at 7-10 days later
Apples & Pears 1	.5 – 2 L 1	1. 1 st at 42 days before harvest. 2. 2 nd at 28 days before harvest. 3. 3 rd at 14 days before harvest.
Peaches, Nectarines & Plums	1 – 2 L	1. 1 st at 28 days before harvest. 2. 2 nd at 14 days later.
Subtropical fruit e.g.: Citrus & Mango's	2 L	1. 1 st at 42 days before harvest. 2. 2 nd at 28 days before harvest. 3. 3 rd at 14 days before harvest.
Various crops	1 – 2 L	Application at 14 days intervals as needed.

COMPATIBILITY

ColourUp is compatible with most pesticides commonly used on vegetable, fruit and agronomic crops.

Caution: Do not use with Dormant Oil, Lime, Sulphur, Spray Lime or high alkaline spray materials. The use of *Nu-Film P*[®] (Reg. No. L2980 of Act 36 of 1947) or *Nu-Film 17*[®] (Reg. No. L2981 of Act 36 of 1947) will help control the foliar absorption of **ColourUp**. Do not use penetrating type surfactants or oils with **ColourUp**.
